The Purpose of the minor variance is to allow construction of 300 square meters of covered storage over part of the subject lands where outdoor storage and loading was permitted by Zoning Bylaw Amendment 2017-125, which allowed a 704 square meter woodworking shop (including office, lunchroom, and power room) and 320 square meters outside storage.

The Effect of the proposed minor variance is to permit construction of 300 square meters of covered storage on the subject lands where outdoor storage and loading was previously allowed.

Property owners within 60 meters of the subject land are hereby notified of the above application for consent. The property to be severed will be marked by a sign.

If a person or public body has the ability to appeal the decision of the Committee of Adjustment in respect of the proposed consent to the Ontario Land Tribunal but does not make **written submission** to: Committee of Adjustment, Township of Southgate office before it gives a provisional consent, the Tribunal (OLT) may dismiss.
