**The Purpose** of the Minor Variance is to allow a one storey "single wide" mobile home with 90 square meters of gross floor area on-site with no basement or cellar. Current zoning permits a one storey single detached dwelling with 105 square meters minimum gross floor area without a basement or cellar as a "double wide" mobile home . A variance of 15 square meters gross floor area is required to permit the proposed one storey "single wide" mobile home as a single detached dwelling unit.

**The Effect** of the Minor Variance would be to permit a one storey "single wide" mobile home with 90 square meters of gross floor area with no basement or cellar on-site.

Property owners within 60 meters of the subject land are hereby notified of the above application for minor variance. The property will be marked by a sign.
