Hi Clinton,

I reviewed the material posted on the Township's <u>website</u> with respect to OPA 2 – Source Water Protection, specifically the draft document entitled "Amendment No. 21 to the Township of Southgate Official Plan" from September 2018 (attached).

I do not have any comments about the text of the document.

However, please note that the map schedule that is part of the proposed amendment does not reflect the Wellhead Protection Area (WHPA) as per the currently approved Grand River Source Protection Plan. The map is consistent with the new WHPAs that include the new municipal Well D5. While the technical work has been completed, work is now in the process as part of the requirements under the Clean Water Act, 2006 to updated the Grand River Source Protection Plan with this new information. We anticipate that the updated Grand River Source Protection Plan is submitted to the Ministry of the Environment, Conservation and Parks for the Minister's approval in April 2019, following review by the Lake Erie Region Source Protection Committee and formal public consultation. You may want to consider the possibility that the mapping may change as part of the review and approval process of the updated Grand River Source Protection Plan. Maybe some language could be included in the proposed amendment to account for this.
