All wells when drilled are subject to pumping tests at the time of installation and the results are posted with the well record.

GM Blue Plan did not conduct new tests on the surrounding wells as part of this study.

I meant to send another email to you. I found the original zoning by-law notices. And this notice is the Committee of

Just curious.....
